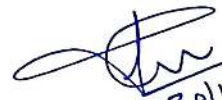
The appointment is purely on temporary and on tenure basis as per residency scheme

1. The appointment shall be subject to medical fitness and verification of certificates. (a) He/she will have to get himself/herself medically examined by the Chairman, Medical Examination Board, M.V. Hospital, before joining in the department. (b) In case of women candidates, the appointment will be subject to G.I.D.P. & A.R.O.M.No. 14034/4/84/Estt(D), dated 13th Feb, 1985 due to hazardous nature of job.
2. That appointment will be terminated at any time giving 24 hours notice without assigning any reason thereafter.
3. The Private Practice of any kind what so ever is strictly prohibited. Besides the candidates will not work simultaneously as SR in any other hospital. Breach of this condition will result in termination of appointment.
4. Other condition of service will be governed by relevant rules and orders from time to time. If any declaration / information furnished by his/her prove to be false or willfully suppressed, he/she will liable to be removed from the service and/or any other action Govt. may deem necessary will be taken & no salary will be paid if served in due course of time, what so ever it be.
5. His/her appointment subject to his taking of an oath of allegiance / faithfulness to the constitution of India or making solemn affirmation to the effect that he/she is having one wife/ husband and he/she is not married to a person / woman who is already having one living wife/husband.
6. He/She should submit a Character Certificate from a Gazetted Officer or Magistrate.
7. If the term & conditions mentioned are acceptable to him/her, he/she will report to the undersigned during working hours (with the copy of this offer of appointment and also result copy), immediately or

maximum within 07 working days from the date of issue of this letter and furnish in writing explicitly that all the terms and conditions of appointment are acceptable to him/her. If no reply is furnished within the prescribed time limit, the offer of appointment will be treated as cancelled without any further correspondence.

8. The period of service rendered by you as Senior Resident in Govt. Hospital/ Autonomous Bodies founded by the Govt. prior to this appointment, if any, will count while reckoning the tenure as Senior Resident. An undertaking stating that he/she has not worked as Senior Residency anywhere in India before this appointment. In case he/she has done residency in any Govt./Public Sector Hospital, the period thereof should be mentioned at the time of joining, as the same will be adjusted against the fixed tenure of Senior Residency.
9. In case of resignation before completion of duration of service offered, they are required to give an advance notice of one month, failing which one month salary would be recovered. No any kind of leave will be given during the notice period of resignation.
10. The resident doctor must follow BMWM Practices as per guidelines of DPCC. For any query, he can contact Nodal Officer [BMWM], Lab. Department of this hospital & must complete BMW orientation classes before joining.
11. Delay in completing the formalities may delay the release of salary and this will be his/her individual responsibility.
12. After completion of tenure (what so ever the case be, resignation/termination/tenure completion) the official has to get his/her codal formalities (No Dues etc.) within next three months otherwise the candidate will lose the claim of salary, basically this will be his/her individual responsibility.
13. He/ She is required to submit Delhi Medical Council Registration certificate before joining.
14. Delay in completing the formalities may delay the release of salary and this will be his/her individual responsibility & non submission in TWENTY days will result in automatic termination and no salary shall be paid for that period.
15. No salary will be paid for any kind of unauthorized absence from duty even by the name of Strike.
16. In case of unauthorized/willful absence of duties for more than 7 days, the appointment shall be terminated without assigning any reason.
17. No T.A & D.A. will be admissible to join the duty.
18. Application to hostel accommodation is optional. The selected candidate may apply for the hostel accommodation immediately if required. The entitlement for HRA will be as per Govt. Rules. Not abiding by rules and regulation, as contained in the allotment letter of hostel accommodation, may lead to serious penalty and may cause termination of appointment also.
19. In case the offer is acceptable, he/she should submit acceptance stating willingness to join duties within seven days from the date of accepting the offer letter, failing which it will be presumed that he/she is not interested to join. The offer will be cancelled without any intimation after the due date.
20. Litigations if any will be in the jurisdiction of Delhi.
21. He/She should attend CME held in this hospital on any working day/off day, otherwise the tenure will not be extended.
22. He/She should submit the details of ADHAAR, Bank Account along with self attested copy of PAN while joining.

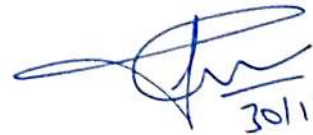
